- Teams Competing:** Available to any Colorado High School team interested in participating and developing team unity and gain competition experience
- When:** Thursdays (six Thursdays over the summer, June 12, 19, 26 and July 10, 17 and 24<sup>th</sup>)
- Time:** Competition begins at 6:00pm through completion
- Skin Check:** Will be done prior to each competition by the coaches
- Weight-in:** On each day of competition, two scales, in uniform and wrestling shoes.
- Set-up:** Four mats will be set up for competition each evening and Colorado School of Mines wrestlers will be officials for the matches
- Fee:** \$500 per team, for your entire squad, **roster of your team must be submitted with applications and payment. Only those wrestlers listed on your roster will be able to count at a team rate: or \$65 per individual**
- Registrations:** All students will be required to fill out a hold harmless agreement before they will be allowed to compete, see opposite page
