


# Active Project Update



#### 14<sup>th</sup> Street

- Extend 14<sup>th</sup> street from Illinois to Maple street
- Remove Parking and to through traffic
- Some landscape improvements
- Work to start July
- Tracking fall 2020 completion







### Parking Garage 1

- 760 spaces
- 23,000 sf of classroom/office space
- Project is 85% complete
- Tracking summer 2020 completion






• Most of the remaining work is interior, site work and landscape



### Spruce Hall

- Meets the need for all freshmen living on campus
- 420 beds, 110,000 SF
- Project is 90% complete
- On target for Summer 2020 completion

### Campus Utility Infrastructure Improvements

- New steam and chilled water infrastructure
- Steam and Chilled Water on 18<sup>th</sup> street finished this summer
- Second phase of work (within existing tunnel) on Maple at 16<sup>th</sup> Street through fall 2020
- Future tunnel work crossing Illinois St. within 18<sup>th</sup> St. to Cheyenne St pending Frontiers funding
