# **Preapproved Colorado Community College System (CCCS) Courses**

Colorado School of Mines is a signatory to the Colorado Statewide Engineering Articulation Agreement. Beginning with admissions in 2003-2004, this agreement determines transferability of coursework for engineering students throughout the State of Colorado.

Numerous courses from the Colorado Community College System (CCCS) have been preapproved to transfer, provided a grade of "C" or higher has been earned. If you are a currently enrolled Mines student intending to take a CCCS preapproved course, please have the appropriate CCCS school send an official transcript to [transfer@mines.edu](mailto:transfer@mines.edu) after completion of the course(s).

**No additional approval forms are necessary.** Please allow 2-3 weeks for the credit to post to your record at Mines after the official transcript has been received.

To view the preapproved courses, select from the categories below:

- Core and General Courses
- CAS/HASS 2xx Mid-Level Elective Courses (different from HASS 200 – Global Studies)
- Computer Science and Engineering Courses
- Free Electives – Academic-based courses not listed on the other CCCS preapproved lists will transfer as free electives up to the number of hours needed to meet your degree requirements at Mines.

Note: No credit will be granted for vocational courses (such as carpentry, medical assisting, etc.), or for developmental courses, including math and science courses below the level to be applicable to a Mines degree, such as pre-calculus or introductory chemistry.
