Approval of Minutes – September 14, 2022

MOTION: To approve the Research Council minutes of September 14, 2022 by Rostami, seconded by Spear. Motion passed unanimously.

Updates

Research Advisory Board

Lisa Kinzel

RAB had met for the first time in 2022; members from each department. List of ten initiatives was condensed to three to work on for the upcoming year. RAB to work on how Mines can better work with national lab partners across the nation; one group working on how to work on joint appointments, visiting scholars, and better exchanges of students. RAB to work on research infrastructure; better use of research resources to support the research enterprise, looking at ways to maximize infrastructure of research on campus. Kinzel noted infrastructure has been an ongoing discussion within RTT and the RAB. Third topic on open versus restricted research did not have much RAB engagement.

Open versus Restricted Research

Lisa Kinzel

Subcommittee of RAB charged with examining institutions that conduct significant restricted research and how thesis and dissertations, publications, and other processes are managed. Charged with determining if these institutions have a Sensitive Compartmented Information Facility (SCIF) and what that SCIF nature is, how it is staffed, and other aspects.



Federal law passed requiring publication in open access starting 2026. Councilor noted there is a SCIF located in Colorado Springs on Peterson Air Force Base. SCIFs increase complexity and may cause issues; Councilor reported administratively difficult for a school that is publicly funded.

Discussion had been tabled at RAB; topic requires addressing due to federal involvement and growth of the institution as a research entity. SCIF are separate from the open versus restricted access discussion.

 Question if the library has funds to assist in covering this change; very limited amount of funds dedicated to supporting open access. Publishers are accommodating of requirements but a charge would be associated with open access journals. Suggestion made that faculty be prepared to write within grants regarding publishing fees.

Saleh asked faculty to consult with departments and begin discussions on open versus restricted access.

Mines Venture Fund Number One

Mines Venture Fund raised five million dollars. Six startups are to present 10/6 for a chance to receive funding. Saleh noted this is a commercialization opportunity and submissions begin every quarter.
