Previous Minutes. The minutes of the meeting held on October 1, 1965 were approved.

New Faculty Appointments. President Childs reviewed the following faculty appointments:

Elsie Christine Ericson Catalog Librarian	\$6,250

Ross M. Lyon Instructor in Basic Engineering	6,300

The Board approved these appointments.

Commencement Speaker. President Childs reviewed possible speakers for Commencement, 1966. The Board authorized President Childs to arrange for a Commencement speaker.

Candidates for Medals. President Childs was instructed to make further inquiry with regard to Abdul Aziz Al-Wattari who was recommended for a van Diest Gold Medal last year.

Mr. Eisenach was appointed by Dr. Parker as Chairman of the Board committee to make recommendations to the entire Board for Distinguished Achievement Medals. Mr. Stockmar and Mr. Fenwick were again appointed to serve on the committee. The files were to be ready for distribution to the committee at the December meeting.

President's Annual Report. President Childs reported that according to word received from the Management Analysis Office of the state capitol the publication of an annual report for this past fiscal year was at the discretion of the School. In the future, the requirement for reporting to the Governor and the General Assembly will be satisfied by the Operational Report as provided for in Proposed Fiscal Rule 33 which stipulates that all state agencies will submit an annual operational report. ✓

The President recommended that the School not publish the usual annual report this year but follow the format of the new operational report. The Board approved this recommendation.

Mines Chaplain. President Childs reported to the Board that several faculty members had discussed with him the possible need for a full-time minister on the campus. Dr. Martin Fuller, together with other interested faculty members, had prepared a brochure setting forth the proposal and had asked that the brochure be examined by the President and the Board of Trustees. Copies of the proposal were distributed to the members of the Board. ✓

Institute for Extractive Metallurgy. Copies were distributed of a report on the activities of the Institute for Extractive Metallurgy.

Mr. Steinhauer entered the meeting at this time.

Monthly Reports. Mr. Steinhauer reviewed the monthly reports as follows: Summary of Budget Appropriation & Disbursements, as of October 31, 1965; Balance Sheet, October 31, 1965; Mill Levy Building Fund, as of October 31, 1965; Experimental Plant, Summary of Budget Appropriation & Disbursements, as of October 31, 1965; Statement of Income and Expense, Mines Park Addition and Houses No. 1, as of October 31, 1965; Statement of Income and Expense, Houses Group 2, as of October 31, 1965; Analysis of Cash Position, Operations Pledge to Open End Bond Issue, October 31, 1965; C.S.M. Athletic Association, Comparison of Receipts and Disbursements to Budget, as of October 31, 1965; Budget Period, Health and Accident Fund for the Associated Students of the Colorado School of Mines, as of October 29, 1965; and the Research Services Fund reports as of October 31, 1965.

CSM Research Foundation, Inc. President Childs reported that the CSM Research Foundation will purchase the Kerr-McGee plant at 5950 McIntyre for further expansion of their work.

Transfer of Funds from Group II Houses. Mr. Steinhauer reviewed the status of efforts to transfer the balance of \$24,226 in Housing Group II fund to the Bond and Interest Sinking Fund account for Mines Park Addition. Authorization had been sought from the State Controller. The State Controller had replied that inasmuch as houses in this group had been purchased with State funds, any revenue from these houses should be deposited in the general cash fund. Mr. Steinhauer recommended that legislation be introduced in the next session to allow the School to deposit these funds in the Bond and Interest Sinking Fund account for Mines Park Addition.

The Board approved this action and hoped it could be done during the 1966 short session of the legislature.

Bond Coverage for Mr. Steinhauer. Mr. Steinhauer reported that as instructed by the Board he had made inquiry into the amount of bond carried on other business managers in state-supported schools. This study was a result of comments made in the audit report for 1963-64. As a result of information gathered by Mr. Steinhauer as to bond coverage of other business managers and in view of the limited exposure in our organization, the Board of Trustees concluded Mr. Steinhauer was adequately covered by his present bond.

Titan I Missile Complex. President Childs reviewed the wish of the Geophysics Department to use Titan I Missile Site to be utilized as a geophysical observatory in a current study of the seismicity of the Denver area. The Air Force had submitted a letter of agreement covering the use by the School of these facilities.

The Board authorized signature by President Childs of the letter of agreement but suggested that operating costs should be checked carefully before more extensive use of the missile site is agreed upon.

Fraternity Taxes. Mr. Steinhauer reported on the situation as it stands with the County Assessor. Mr. Braden, County Assessor, had agreed to attempt a solution but with the 60 percent maximum depreciation still continuing. Mr. Lester C. Thomas had asked that the School assume the financing of the two new fraternity houses and thus resolve the tax situation.

The members of the Board were of the opinion that the School could not assume the financing of the two new houses unless a similar arrangement could be worked out with the other fraternities which was precluded by the legislation passed at the last session of the General Assembly.

Mr. Steinhauer was instructed to investigate the details of the last aid to higher education act passed by Congress to determine if there was any change which would make funds available for construction of fraternity houses. If such funds were available through federal sources, this fact would have an effect on the entire situation.

Proceeds of Prospector Park Sale. Mr. Steinhauer reported that the Highway Department had remitted \$23,000 for the sale of land at 19th and Highway 6 and an amount of \$19,500 for the sale of the buildings. The State Controller had ruled that the \$19,500 could properly be credited to the Bond and Interest Sinking Fund Account for self-liquidating properties.

The State Controller on advice from the Attorney General stated that the \$23,800 received from the sale of land would have to be put in the general fund, and the Colorado School of Mines could introduce a bill in the legislature asking that this amount be appropriated to the School for purchase of additional property. Mr. Steinhauer suggested that an alternative would be to return this amount to the State Highway Department and request them to negotiate for property in this amount to be transferred to the School. This procedure would require the concurrence of the State Controller and Mr. Steinhauer was directed to confer with Mr. Shea on this procedure.

Sudler Claim. This item was postponed until Mr. Stockmar could be present.

Beer - College Union. This item was deferred until all members of the Board could be present.

The meeting adjourned at noon.

Previous Minutes. The minutes of the meeting held on November 12, 1965 were approved.

Meeting - Department Heads and Board of Trustees. President Childs stated it would be very helpful in guiding faculty curricula studies with regard to the new degree program if the members of the Board could meet with the department heads. He felt the department heads needed the benefit of the philosophy and the direction desired in the change. The members of the Board were willing to hold such a meeting and thought it would be constructive.

It was agreed that the Board would meet in the President's Office at 6:00 p.m. on Monday, January 4, 1966. The Board would then meet for dinner with the department heads at 7:00 p.m. in the college union.

Meeting with the CSM Research Foundation. A date for a meeting of the CSM Research Foundation Board and the members of the CSM Board of Trustees was set for lunch on Wednesday, January 5, with the meeting to follow lunch.

Carillons. President Childs reported to the Board that he had consulted with student leaders and they were almost unanimous in their approval of the carillons. He reported that he had then written to the Guggenheim Foundation to solicit funds to pay for the carillons. No response had yet been received.

Mr. Steinhauer entered the meeting at this time.

Monthly Reports. Mr. Steinhauer reviewed the monthly reports as follows: Summary of Budget Appropriation & Disbursements, as of November 30, 1965; Balance Sheet, November 30, 1965; Restricted Funds, November 30, 1965; Mill Levy Building Fund, as of November 30, 1965; Restricted Funds, Schedule 2, November 30, 1965; Experimental Plant, Summary of Budget Appropriation & Disbursements, as of November 30, 1965; Statement of Income and Expense, Mines Park Addition and Houses No. 1, as of November 30, 1965; Statement of Income & Expense, Houses No. 2, as of November 30, 1965; Analysis of Cash Position, Operations Pledged to Open End Bond Issue, November 30, 1965; C.S.M. Athletic Association, Comparison of Receipts & Disbursements to Budget, as of November 30, 1965; Budget Period, Health and Accident Fund for the Associated Students of the Colorado School of Mines, as of November 30, 1965; Research Services Fund, Summary of Receipts & Disbursements, as of November 30, 1965; and the Computing Center Budget Sheet as of November 30, 1965.

Sigma Alpha Epsilon House. President Childs reported on a letter received from Mr. Leo Bradley who represents the SAE house corporation. Mr. Bradley stated they would accept the School's offer of \$67,500 for the house. He asked for a statement of policy in connection with the School's future dormitory plans and asked that the fraternity be given a three-year option on a lot on fraternity row. He asked that monthly rental of \$350 be set for the use of the property as long as the fraternity uses the house.

Mr. Steinhauer and President Childs recommended that rent be set at \$500 per month for the nine-month school year in line with

the rent agreed upon under similar circumstances with SPE with some adjustment made for the summer months dependent on the number of students occupying the house. The Board accepted this recommendation.

President Childs stated he would like to establish a target date of August 31, 1967 for the acquisition, razing, and landscaping of the central campus area which would include the SAE house. The Board approved this time schedule.

The Board approved the granting of an option on a lot on fraternity row at a price of \$6,000 with a deposit to be made by the SAE house corporation.

As for the School's policy on dormitory housing, the Board instructed President Childs to advise Mr. Bradley that when sufficient facilities were available the School may require all unmarried freshmen, other than those who live at home, to live in the dormitories. However, such a policy must be subject to change under changing conditions.

New Mining Engineering Building. President Childs called attention to the fact that this year's capital construction budget contains a four-year building plan for a new building to house the Mining Engineering Department, Basic Engineering, and possibly Mathematics. The School has asked for \$69,000 to start the planning.

The Board members felt very strongly that the new building should be known as the Mining Engineering Building.

Fraternity Taxes. President Childs reviewed for the Board recent discussions held between Mr. Braden, Mr. Thomas, and Mr. Hudiburgh with regard to taxes on the two fraternity houses built on the west campus. Mr. Braden, the County Assessor, is willing to depreciate these structures to a minimum in a six-year period and if the School will get behind the loans, he has reportedly promised that the back taxes and the current taxes will be deleted. This would in effect be the School collecting from the house corporations (as a self-liquidating dormitory), reimbursing the CSM Foundation which would reimburse the Denver United States National for the loan.

Mr. Steinhauer was instructed to get the opinion of the Attorney General as to whether the School could enter into such an arrangement.

Liability Insurance for Faculty. President Childs reported that members of the faculty were concerned about possible liability in accidents which could happen in laboratory courses and field work. Mr. Steinhauer stated that the School is protected under our general liability insurance.

The members of the Board recommended that the School policy be reviewed to determine whether or not it could be made to include the School, employees, and agents without changing present premiums.

Joint Honor Scholarship Replacement. President Childs reported to the Board that the Joint Honor Scholarships had been discontinued by the college presidents because of concern over the administration of these scholarships. President Childs had asked

the School scholarship committee to make a recommendation for a scholarship program to replace these.

The Board members were of the opinion that these tuition-waiver scholarships should not be limited to resident students but instead should be based on a percentage of residents and nonresidents as reflected in the previous graduating class. The total amount of dollars involved in tuition-waiver scholarships at state-supported schools had been set at 15 percent of the student receipts by the presidents.

Sale of Land to Highway Department. Mr. Steinhauer reported that as instructed at the last Board meeting, he had conferred with the State Controller about returning the Highway Department check in the amount of \$23,000 for the sale of land at the intersection of 19th Street and Highway 6 and asking the Highway Department to buy property we needed in exchange for the land. The State Controller had given verbal approval of this transaction.

Mines Chaplain. President Childs asked for instructions to the faculty committee that had prepared a brochure setting forth a plan for a chaplain for the campus. The Board members did not regard the plan as being feasible.
